Reports

Superintendent Report – Acting Superintendent Anne Landry was present

AOE released a snapshot of the assessment data. SU was noted to need equity support. Des Hertz is working with AOE to see how the SU can support this.

Principal Reports –

Barnet – Luisa is at the Pbis Conference at Killington. No questions.

Walden – Things are going very well. Diving into the curriculum. Assessments are finishing up. Community work has started – reaching out to many organizations. Nature's Classroom is coming next week.
